* After the 54th day, only initiatives, alternatives to initiatives, budgets and matters necessary to implement budgets, messages pertaining to amendments, differences between the houses, and matters incident to the interim and closing of the session may be considered.

— Last day to read in committee reports in house of origin, except House fiscal committees and Senate Ways & Means and Transportation committees.

— Last day to read in committee reports from House fiscal committees and Senate Ways & Means and Transportation committees in house of origin.

— Last day to consider bills in house of origin (5 p.m.).

— Last day to read in committee reports from opposite house, except House fiscal committees and Senate Ways & Means and Transportation committees.

— Last day to read in opposite house committee reports from House fiscal committees and Senate Ways & Means and Transportation committees.

— Last day to consider opposite house bills (5 p.m.) (except initiatives and alternatives to initiatives, amendments, differences, and business related to the interim or closing of the session).

— Last day allowed for regular session under state constitution.

The Governor has 5 days, excluding Sundays, to take action on any bill passed by the Legislature, provided adjournment does not occur within those 5 days.

The Secretary of the Senate's office has received a number of requests regarding cutoff dates from those preparing schedules or planning events for the upcoming session. Attached you will find a DRAFT 2008 cutoff calendar. It reflects short session cutoff dates based on the 2006 cutoff resolution. The final cutoff calendar will depend on a joint House/Senate agreement as defined by a concurrent resolution usually passed during the first week of session. The adopted cutoff resolution may or may not follow this draft.
