LATCH Opens Roxbury Cooperative

On June 3, the Lutheran Alliance to Create Housing (LATCH) will celebrate the grand opening of Longfellow Court and Westwood Court Cooperatives. Located in the Westwood neighborhood in West Seattle, at 27th Avenue SW and SW Cambridge Street, the projects are part of the Seattle Housing Authority's Hope VI grant to redevelop Roxbury House and Village.

As part of the revitalization of Roxbury, SHA has granted LATCH a 99-year lease on the land and is lending them \$1.2 million for the 45-unit project. In return 15 of the units will be reserved for families on the waiting list for or already living in public housing. The new LATCH units replace 60 units of deteriorating town homes that were owned by SHA. In addition to the LATCH units, SHA is renovating Roxbury House, 151 units for low-income seniors and people with disabilities. All former Roxbury residents were offered relocation assistance including Section 8 vouchers, moving to other SHA units, down payment assistance or relocation allocations. At this time only three former residents have indicated an interest in returning to Roxbury.

Longfellow Court and Westwood Court Cooperatives feature seven one-bedroom flats, thirteen two-bedroom units and twenty three-

bedroom townhouses, six four-bedroom, and one five-bedroom apartment. (The four- and fivebedroom units are reserved for SHA tenants.) The project is configured as two separate cooperatives divided by a private street. Public housing residents (those in the SHA units) will pay one third of their income for rent and utilities. The other units will serve families making between \$22,000 and \$31,000 a year. These units will rent for between \$565 (one-bedroom) and \$750 (three-bedroom). The projects will be managed using the cooperative housing model. LATCH has successfully used this model at several of its projects. Each resident will share in the property's management and maintenance by contributing time, energy and a variety of skills. LATCH feels that the cooperative management means the difference between providing housing only and providing a space that fosters community as well as providing housing.

Funders for the project include: the Seattle Housing Authority, the Bank of America, the National Equity Fund, the City of Seattle's Office of Housing, the Office of Community Development, HUD and the Federal Home Loan Bank. Weatherization funds came from the City of Seattle's Built Smart Program. The architect for the project was Tonkin/Hoyne/Lokan. The general contractor was Walsh Construction.

Get to Know HDC's Officers

For the third in our series of HDC officer profiles we turn to HDC's Secretary **Lynn Davison**. Lynn is executive director of Common Ground, a statewide organization providing development services and technical assistance to non-profit housing organizations across the state. Common Ground was a founding member of HDC. Lynn joined the HDC board in 1998. Here are some of the questions we asked Lynn:

Where did you grow up? Buffalo, New York (although I have lived here 25 years and have

convinced all my immediate family that this is the place to call home).

Where did you go to college? 3 degrees and 3 schools. Pretty boring stuff.

What was your previous career history? Occupations include riding instructor, bottle washer, phlebotomist, maid, cook, medical technologist, college professor, souvenir seller, public health department manager, electric utility environmental director, county mental health system director, consultant, and non-profit executive director.

How did you get in to the housing field? Working in public health and mental health for 15 years taught me that the single best predictor of selfsufficiency and/or successful treatment is the presence of stable housing. I funded a lot of community based housing while working in mental health and wanted to work more directly to preserve and create low income and special needs housing.

What is your housing philosophy? Housing is the foundation for building healthy individuals, families, and communities.

What would you like to accomplish in the next five years for affordable, low-income housing? I have goals in two areas. The first relates to supportive housing. I would like to see new public and private sources for operating dollars as well as effective collaboration between mainstream service systems and housers. The second relates to the private for-profit sector. I would like to see a significant increase, incentive based, in production of affordable housing by private developers. In addition, I hope to see more contributions from individuals, corporations, and foundations for the development and operation of housing for the lowest income people.

How long is your commute to work? One hour each way by car, ferry, and foot (no traffic ever!).

Hobbies? Like most transplants from other parts of the world I spend a lot of time recreating in the outdoors using various methods of transport (feet, bikes, boats, skis). I am a photographer. I love looking at (and very occasionally buying) art. My gardening skills are growing ... first grudgingly and now with some pleasure.

What did you think you would be when "you grew up"? Haven't done so yet.

What is your favorite type of music? I am a child of the '60's.

Where is your ideal destination for a vacation? Done lots of traveling in my day. The next up on our list are Turkey and Vietnam.

Are you on the board or involved with any other organizations? Chair of the Washington Low Income Housing Congress, involved with the Vashon Maury Island Land Trust.

Bush Tax Cuts Effect on Washington

Citizens for Tax Justice has released "The Bush Tax Cuts, State by State." The study looks at the impact of the proposed Bush tax cut on taxpayers in each of the 50 states. The proposed cuts are shown as if they were fully effective in 2001, although they will not actually be in place until 2011.

In Washington 19.2% (537,000) of taxpayers will receive no income tax cut from the Bush plan. The poorest 20% of Washington tax payers (average income \$10,100) will get an average tax cut of \$76, while the top 1% of Washington taxpayers (average income \$1,151,000) will see a \$55,021 reduction in taxes. HUD Secretary Mel Martinez's Plans

On April 25, the Senate Subcommittee on Housing and Transportation held a hearing on HUD's Program Budget and Management priorities for 2002. HUD Secretary Mel Martinez was among those testifying. His testimony is a chance for activists to get a better idea of Martinez's philosophy and plans for HUD.

"In the past, there has been too much emphasis on programs and budgets and not on people and results," said Martinez. "I have four main objectives during my tenure at HUD: 1) focusing on people not programs; 2) bringing a discipline and accountability to HUD so that there is not a misuses of resources; 3) to be a good steward of our resources; and 4) to run the department ethically."

Secretary Martinez said that he plans on eliminating The Community Builders Program and will move personnel to other areas of HUD that have greater focus and accountability.

When questioned about capital funds Martinez said, "HUD commissioned a study with Abt Associates at some expense, which indicates that LHA's [local housing authorities] could not utilize more then \$2.3 billion for capital projects this year. No roof that needs fixing this year will go unfixed. There are accrued and unencumbered funds. Putting unused funds on top of unused funds is untenable." Sen. Sarbanes (D-MD) responded by providing statistics showing that all capital funds since 1998 have been obligated and/or spent within the time frames set for them. He also reminded the Secretary that HUD could always recapture unspent funds from local housing authorities. Sen. Reed (D-RI) asserted that local housing authorities could absorb more then the \$2.3 billion in capital funds. Martinez said that he would follow-up on the subcommittee's questions about the impact of the \$2.3 billion proposed capital fund budget.

Martinez noted that he hopes to eliminate budget indiscretions by LHAs and believe that HUD's new budget will help bring about more strict use of funds. Martinez also said that he plans to empower local field offices and decentralize the decision making process.

Finally the Secretary stated that he was very supportive of the President's faith-based initiative.

Cost of Housing the Mentally Ill

A new study shows that the cost of housing persons with mental illness is essentially the same as the cost of allowing them to remain homeless. Conducted by researchers at the University of Pennsylvania's Center for Mental Health Policy and Services Research, the study tracked the cost of 4,679 mentally ill homeless people in New York City for two years while they were homeless and two vears after they were housed. The study found that the average homeless mentally ill individual used \$40,500 worth of publicly funded services every year. These services include trips to the emergency room, psychiatric hospitals, shelters and prisons. On the other hand a mentally ill person living in supportive housing (with mental health assistance) use about \$41, 494 in funds, a difference of only \$991. The study did not account for the personal benefits the subjects received from being housed, nor did it consider the economic and aesthetic impact the housing of the mentally ill had on New York City's neighborhoods. Tacoma Voters Reject Housing Bond

On May 15 Tacoma voters said no to a \$5 million housing bond, with 46.64% for and 53.28% against. Housing was one of four bond measures that were voted on in the special election. In order to pass, each measure needed 60% approval, but only one was able to obtain even 50%. The other bond issues included funds for a new police headquarters, neighborhood improvements and improvements to the city's baseball stadium. The total bond package would have been \$60 million. The \$5 million for housing could have been used to build 400 low-income apartments. Denny Hunthausen, an advocate of affordable housing called the bond failure a step backward for creating low-rent housing in Tacoma. "It's going to become a bigger issue over time as people continue to pay a higher percentage of their income for rent," he said.

Budget Outline - The House and Senate have both passed the Bush budget outline. The outline provides for a 1.25 trillion dollar cut over the next 11 years and aims to limit federal spending increases to 4 percent. The budget outline does not usually hold much water during the appropriations process, though Republicans are vowing to enforce it this time.

H.R. 1652 - The Earned Income Tax Credit

Reform Act of 2001 – Introduced by Rep. Mac Collins (R-GA), the bill seeks to reduce the amount of Earned Income Tax Credit by making low-income individuals without children ineligible for the credit. The bill has been referred to the House Ways and Means Committee with no co-sponsors.

H.R. 1687 - National Commission on Marginal Tax Rates for The Working Poor -

The bill would establish the commission and charge it with determining the total effective marginal tax rate from all taxes and benefit phase-outs that a person is subject to, for all earning levels between \$7,000 and \$30,000 per year, in at least five states.

H.R. 1629 - Raise Multifamily Mortgage

Limits – This bill was introduced by Rep. Marge Roukema (R-NJ) and Barney Frank (D-MA) and would raise the FHA multifamily mortgage limits by 25%. The bill is endorsed by HUD and some housing groups. It has been referred to the Financial Services Committee.

S. 739 - Homeless Veterans Assistance -

Introduced by Sen. Paul Wellston (D-MA), this bill would encourage federal, state and local departments and agencies to work toward the national goal of ending homelessness among veterans within the decade. The legislation would establish an Advisory Committee on Homeless Veterans within the Department of Veterans Affairs. The bill has 12 co-sponsors and has been referred to the committee on Veteran Affairs.

State Legislative Update

The State Legislature is halfway through their special session, which is due to end on May 24. To date there has been little progress on the operating budget. Housing bills still on the table are budget-related and have yet to be acted on.
