Federal Watch

Housing Preservation Matching Grant Act of 1999 (HR 425) Introduced this year by Minnesota Congressman Bruce Vento, HR 425 would provide HUD grants to states to preserve HUD properties that are either insured and subsidized, subsidized with state agency loans, have HUD-held loans but formerly were subsidized, or have project-based Section 8. The bill would require a state match of at least 1 state dollar for every 2 federal dollars. The current version of the bill does not allow tax credits or bond resources to be counted as part of the state match. Each state would apply to HUD for the funds and then allocate the funds to specific properties. The grants can be used for acquisition, preservation incentives, operating costs, and capital expenditures.

Housing advocates are currently working to urge their Congressional representatives to sign on to co-sponsor the bill. A sample letter is included with this newsletter. For more details, contact Laura Stravino at the Coalition to Preserve Section 8 Housing, 206/442-9455.

The bill still needs some work, and the bill sponsors are treating it as a "place holder" while details are worked out. There is a concern that in order to fund it, Congress would have to subtract from other housing funds such as HOME. Advocates insist it should be a new program, with new funding not subtracted from other HUD programs.

Meanwhile, the sand slips through the hourglass. Our state has lost 1,422 project-based Section 8 units since 1996, bringing the remaining total to 18, 903. In Seattle, 8 projects with 394 units have opted out.

State Watch—HB 1345 Passes House

HB 1345, which provides a property tax exemption for nonprofit low income housing, passed the House on a 94-3 vote. Our local legislators worked hard for strong bi-partisan support. Thanks go to Rep. **Al O'Brien** (prime sponsor) (D-1), Rep. **Steve Van Luven** (R-48) who spoke eloquently in favor of the bill, Rep. **Velma Veloria** (D-11), Rep. **Renée Radcliff** (R-21), and of course Co-Speaker **Frank Chopp** (D-43).

The bill now moves to the Senate, where it will need help getting out of Ways and Means by April 5.

Housing Trust Fund: This year it is the House's turn to put out its budget first. After much wrangling due to the even split between parties, the House may release its budget by the end of this week. We still expect to see an increase for the State Housing Trust Fund, but the funds may come in the form of set-asides which advocates hoped to avoid.

What \$ Will Voters See on Their Ballots?

The City of Seattle is looking at some big ticket items to fund over the next six years:

- ◆ Renovation of athletic fields
- ◆ Neighborhood plan implementation
- ◆ Pacific Northwest Aquarium
- ◆ Salmon Conservation
- ◆ Sand Point/Magnuson Park redevelopment
- ◆ Seattle Center Phase II (Opera House, Flag Pavilion, Mercer Arena)
- ◆ Transportation maintenance and rehabilitation (bridges, seawalls, streets)
- ◆ Woodland Park Zoo

The Council has prepared a **draft "Strategic Capital Agenda"** to prioritize and schedule which capital expenditures will go to the voters, 1999-2004. The Agenda excludes the City's utilities, since these have their own process and funding sources. **The needed renewal of the City's low income housing levy is not included.** The report states, "The City's role in housing development is also excluded since housing policies are set through a

different process and since housing rarely competes for the same set of funds.” Given the history of previous housing measures, this view comes as a surprise.

The Seattle City Council will meet as a committee of the whole to hear what capital expenditures the Mayor is proposing for the 1999 ballot, Monday, **April 12** at 2:30, 11th Floor of the Municipal Building. The Council will continue its work on these priorities. A public hearing scheduled for April 5 had to be cancelled since it conflicted with another hearing.

South King County Housing Forum

The South King County Housing Forum, which SHDC helped to form, is focusing its energies on the Pacific Highway South strip known as Midway, near Highline Community College. The idea is to look for redevelopment opportunities including affordable housing. The group now calls itself the “SOKCO” Housing Forum to signal its new sock-it-to’um enthusiasm. SHDC members **Tom Lattimore**, Director of Puget Sound LISC, and **Earl Richardson**, Executive Director of SEED, were recently invited to present ideas of what might be done. Richardson showed the group a different way of looking at things—what appear to be detriments to the community can actually be opportunities for action and new development. Both Lattimore and Richardson suggested that the group might want to consider creating a community development corporation to develop and implement the new vision.

Homeless Assistance - Seattle/KC Consolidated Application to HUD

HUD has released its 1999 NOFA for homeless assistance funds under the Supportive Housing Program, Shelter Plus Care and Section 8 SRO Moderate Rehabilitation Programs. As in past years, the City of Seattle and King County intend to submit a consolidated application on behalf of the region.

Representatives of organizations with existing HUD McKinney grants that expire in calendar year 2000 or anyone who is considering applying to HUD for homeless assistance through the 1999 Seattle-King County consolidated application should

Note that it will be extremely difficult for new projects to get funded through this process, since \$17 million to simply renew the grants for current projects that are expiring—a figure that greatly exceeds the resources expected from HUD for this application.

Redmond RFP for Avondale Site

The City of Redmond is offering 3.7 acres on Avondale Road NE for construction of new multifamily housing. The project is part of a larger development including a neighborhood park and a Habitat for Humanity project. Competition for the site will be based on the benefits the developer can offer the City, such as affordability, willingness to work with Habitat, number of units, etc. The sales price is fixed, based on the City's cost, at approximately \$1.3 M.
