Executive Director Monthly Update

I've made some great discoveries as I've settled into the HDC office. One of my favorites—in the back of a drawer--was the 1970 mortgage amortization calculator book that belonged to HDC Founding ED Carla Okigwe. While the interest rates used then ranged from 6-10 percent, the maximum loan amount featured was \$75,000.



Yes, the price of housing has increased dramatically, and we continue to see unbelievably low interest rates as we gradually climb out of the decimation of the broken housing bubble.

But we're facing other dramatic challenges compared to 1970. Where can we site more housing that is reasonably close to employment? What does that housing look like and how does it function? What does "neighborhood and community" mean today?

The need to address these questions—and to handle the increased costs and layers of administration and compliance brought on by complex funding models—makes our work daunting. And to top it all off, whatever solutions we find today are not going to be the ones that work in the future.

But we're convicted about one thing: having access to safe, affordable, healthy housing in a neighborhood of opportunity is critical for all elements of life success to come together. Conventional wisdom, practical experience and more and more research are validating this conviction.

I recently participated in a United Nations forum held in Seattle, where

celebrating his 20th anniversary with Plymouth. In a year filled with milestones, one project—the Pat Williams Apartments—captures Paul's vision and leadership especially well.

The Williams, Plymouth's 13th and newest residence, opened in South Lake Union this year. Designed by HDC member [SMR Architects](#), it became Washington state's first affordable housing (and only its second Mid-Rise project of any kind) to achieve [LEED](#) Platinum certification.

Lambros notes, "We realized the Pat Williams Apartments could have a big impact on several of our priorities. With LEED certification, we could demonstrate how practical and affordable sustainable design can be. It was also the perfect place to launch our new Recovery Support Program and to continue our commitment to veterans."

All residents of the Pat Williams Apartments are in recovery from addiction and are determined to live a clean and sober life. Half of the units are set aside for veterans.

SMR associate Kate Smith did a fantastic job presenting the Williams at the [Northwest EcoBuilding Guild's](#) "10x10x10 Green Building Slam" on November 16. Kate inspired a very knowledgeable audience with the building's ability to conserve natural resources, lower operating costs, enhance the distinctive SLU esthetic, and nurture a vibrant resident community.



These holistic goals are at the forefront of all of Plymouth's capital projects, including their remodels of vintage downtown hotels (like the Pacific at Third & Marion) and their next new development at Third & Virginia.

Is There Enough Affordable Housing in South King County? [Infographic]

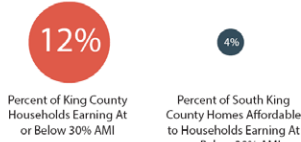
HDC's most recent [infographic](#), focuses on whether or not there is enough Affordable Housing in South King County for the people who live and work there.



Are Homes in South King County Affordable to Very Low-Income Households?

12% of King County households are considered Very Low-Income*, but only 4% of South King County homes are affordable to them. The result is that many very low-income individuals and families in South King County pay more than they can afford for housing, making it difficult to pay for other necessities, such as food, transportation, and childcare.

*For King County Comprehensive Plan purposes, households earning at or below 30% AMI are considered Very Low-Income. The U.S. Department of Housing and Urban Development (HUD) defines households earning below 30% AMI as Extremely Low-Income.
