#### ADVOCATING FOR SAFE, HEALTHY, AFFORDABLE HOMES FOR EVERYONE IN KING COUNTY

HDC uses our collective voice to advocate for policies that foster inclusive, affordable communities at the local, state, and federal levels.

#### LODGING TAX ALLOCATION

In response to the King County Council's proposed allocation of lodging tax dollars, hundreds of housing advocates engaged to encourage the Council to use the funds for affordable housing.

Over 1,000 advocates sent messages and/or testified so we could secure \$165 million more for housing!

#### STATE ADVOCACY

HDC advocated alongside our State partners to make 2018's legislative session a historic year for housing. Including passing HB 2578, banning source of income discrimination, HB 2667, expanding access to the Housing and Essential Needs Program, HB 2382, promoting the use of surplus public property for affordable homes, and HB 2444, clarifying a real estate excise tax exemption for homes built with Low Income Housing Tax Credits

#### POLICY PRIORITY WORKSHOPS

As part of our Advocacy Agenda formation process, HDC hosted three policy priority workshops in Bellevue, Tukwila, and Seattle to engage member feedback. 72 unique staff attended from 31 member organizations







#### **ADVOCACY INTENSIVE**

Our second annual Advocacy Intensive gave 18 staff members from 9 of our member organizations new skills to advocate on behalf of the affordable housing community. Participants learned about issues impacting their work, navigating the local policy environment, and got to test their skills on elected officials and city staff




#### ENGAGING IN STRATEGIC ALLIANCES ACROSS SECTORS AND INDUSTRIES

Since 1988, HDC membership has grown to encompass all the major nonprofit housing developers in King County, as well as the major financial institutions, architects, general contractors, attorneys, accountants, service providers, public housing authorities, and government agencies.

This membership-based network collaborates effectively to provide a wide range of stable and affordable housing opportunities for those who most need assistance. By uniting our shared values, we are better positioned to support the sector's ability to make a substantial community-wide impact.

As a powerful network, we engage in strategic alliances across sectors and industries to respond to diverse community needs - from homelessness to homeownership.

Through workshops, seminars, and trainings, HDC facilitates and provides skill-building opportunities, networking, and peer support, creating efficiencies in design and production to preserve and improve the sector's ability to act as responsible stewards of public resources.





#### ENGAGING IN STRATEGIC ALLIANCES ACROSS SECTORS AND INDUSTRIES

#### South King Housing and Homelessness Partners

HDC convened South King County elected officials and city staff to form an inter-local collaboration that addresses South King County's housing and homelessness crisis with regional collaboration.



#### Tech 4 Housing

HDC became the fiscal partner of Tech 4 Housing, a community of tech workers who believe that the tech boom can and should benefit every resident. Tech 4 Housing works to engage the tech community through educational outreach and advocacy.



#### Seattle for Everyone

HDC, along with Seattle for Everyone partners, continues to work on implementation of the Housing Affordability and Livability Agenda (HALA) recommendations, specifically on passing Mandatory Housing Affordability city-wide (MHA) after the Hearing Examiner ended the year long appeal process in November allowing Seattle City Council to move forward.



"The Seattle for Everyone coalition brought together a broad set of unusual partners—labor and business, environmentalists and urbanists, housing advocates and private developers—at a critical time for moving forward an inclusionary zoning program in Seattle. Over the past several years, the coalition has been instrumental in advocating for the passage of this crucial legislation and stands as an exemplar of what is possible when we unite around a shared vision for a more affordable, equitable city."












HDC works to provide a value proposition for members that earns their on-going support. Member dues comprise about a third of our budget, and the majority of our expenses are on programs design to enrich our members.






