Location: 1000 2nd Ave., Suite 2700; Seattle, WA 98104. Our office is located in

downtown Seattle's Financial District on 2nd Avenue, within walking distance to Pike Place Market and Seattle's scenic waterfront.

This challenging position within the Homeownership Division of the Commission is responsible for coordinating grant writing activities, designs, implements and manages the fund allocation and distribution program for counseling grants with up to 25 non-profits across the state and others as applicable. This position manages and oversees the workflow of all federal, state, and other grants distributed through the housing counseling network. Implements, coordinates and provides reporting and compliance processes of grants to appropriate state and federal agencies. This position manages and oversees the workflow of grants from 5 or more different funding sources. Responsible for verifying accuracy of grant voucher data, amounts, reporting and grant compliance guidelines are met. Responsible for implementing process and performing required audits of sub-grantees.

The **Homeownership Division's** origination programs provide loans for over 7,000 single family homebuyers each year utilizing various funding sources including the mortgage revenue bond programs, daily priced programs and other special programs as determined. We sponsor a statewide program of homebuyer education seminars and housing counselors. We partner with lenders, realtors, non-profits, government entities, and other affordable housing advocates.

The duty station for this position is Seattle, WA. Due to the COVID-19 pandemic, telework (mobile-work) is currently expected. When we are approved to return to the office, the incumbent is expected to report to the Seattle office for work activities. Partial telecommuting and alternative workstations are also options subject to supervisory approval.

Who we are:

The Commission is a market-driven and self-supporting state commission created to provide below-market rate financing for building, purchase and preservation of affordable housing, and non-profit capital facilities, and community services. To achieve its goals, the Commission functions as a financing conduit for developers, lenders, first-time home buyers, real estate professionals, beginning farmers and ranchers, and non-profit organizations to provide affordable financing for homes, rental housing, and cultural and social services facilities. Commission financing does not utilize or impact the state's credit.

Principal Responsibilities:

- Supports and promotes the vision, mission and values of the Commission on a daily basis and with an equity lens to better assist underserved communities and communities of color.
- Develops, administers, and supervises the implementation of all federal, state, and other
 grants and is grounded in social justice and racial equity including, HUD, NeighborWorks,
 CARES, Attorney General, Foreclosure Fairness, and others as applicable. Monitors grants
 for quality; ensures need is being met in all areas of the state; follows up with complaints
 within 3 business days.
- Responsible for the implementation and development of the \$17 million pilot program under the Homeownership Assistance Fund (HAF) in coordination with the Department of Commerce and assists with the development of the larger plan.
- Writes, implements and manage all aspects of housing counseling grants, evaluate funding requests, conducts regional meetings in person and virtually, tracks and reports for housing counseling grants and supervises other fundraising activities as applicable including overseeing audits for multiple counseling grants for nonprofit counseling component of Homebuyer Education Program by respective deadlines.
- Works in partnership with the housing counseling network on current and new initiatives.
 Works in partnership with the Department of Commerce to assist with the administration of grant funds as applicable.
- Works on formulating policies for grants, and as legislative liaison for homeownership division. Coordinates and perform required audits for all grants by respective deadlines. Responsible for processing all grant vouchers in a timely fashion, verifying data, amounts and reporting are accurate.
- Builds relationships with the housing counselors statewide and holds regular meetings with them to support their efforts. Represents the Commission at consortiums, meetings, etc, participates in outreach.
- Creates monthly reports for the Commission and others as requested by respected deadlines.

Desirable qualifications: We are most interested in candidates who meet or exceed the following criteria:

Two years Housing Counseling including pre-purchase, post purchase, reverse equity, and default counseling experience.

Two years grant writing, grant administration and grant audit experience.

Strong ability to analyze funding request submissions by sub-grantees.

Strong public speaking experience.

Strong negotiating skills.

Working knowledge of HUD Housing Counseling program and other federal grants.

Working knowledge of the Commission's First Mortgage programs and down payment assistance programs.

Strong independent problem-solving abilities

Ability to effectively and independently handle, manage and resolve conflicts from funders, housing counselors and sub-grantees.
